MEDICAL CENTER TODAY: INITITAL EXITING CONDITIONS FINDINGS

- Staff is in the process of developing a "Medical Center Atlas" displaying existing land use conditions maps, amenities, natural systems, etc.
- Building footprint data is needed.
 - Square footage vs. available space

- City owned property data is needed.
 - We have GIS shapefiles and layers with city owned property data, however, it may not be the most accurate at this time.
- Staff will need to obtain and display designated green streets, such as Hamilton Wolfe Drive.
- Staff will contact the UTHSCSA chief of police to obtain local crime data.
- A bike "heat map" will be useful to show concentration of bike ridership.
 - MPO or GIS staff may be able to provide more information.
- VIA is in the process of creating a comprehensive data analysis that could provide for more frequent and more effective routes. The analysis is in the beginning phases and public meetings will follow a few months from now.

AMENITIES AND ACCESS

 There is a lack of connectivity in the Medical Center area, however there is potential, through public investments, waivers, or incentives, to enhance amenities and provide better connectivity.

VISION AND GOALS DISCUSSION

- Vison & Goals Exercise:
 - What should the Medical Center look like 20 years from now?
 - Participants wrote down their "vision" and passed it along to their neighbor. The neighbor highlighted key words and phrases.
 - See the planning exercise attachment.
- Discussion: What are the major themes/opportunities/issues the plan should focus on or address?
 - Healthy Living:
 - The medical center should set the educational example.
 - Connectivity to trails, grocery stores, transit, medical services, the senior center, parks and open spaces
 - Partnerships with school districts and church's to establish "Sparks" or use underutilized green spaces.
 - Promote a "nurturing environment" to allow visitors or employees to go outside and enjoy the natural environment and promote informal recreational options and outdoor gathering spaces.
 - Farmers Markets and neighborhood grocery stores to provide convenient access to healthy food.
 - Leverage publicly owned properties to catalyze the vision of a vibrant live, work, play area.

Mobility:

- Improve connectivity to and from the Medical Center area, as well as within by having multimodal forms of transportation such as: transit rails, elevated transit rails, frequent transit, and high capacity capabilities.
- Encourage environmentally friendly transportation by providing more pedestrian and bike lanes, as well as electric charging centers for electric vehicles
- Develop "park once" strategies by promoting access through a shuttle or enhanced pedestrian mobility.

- Mobility (continued):
 - Provide accessibility throughout the area for ADA compliance, seniors and the mobility impaired with a focus on pedestrian comfort and safety.
 - Consider design standards for setbacks and new buildings to ensure pedestrian safety.
- "Become a world leader in medical education and research"
 - The San Antonio Medical Foundation has vacant land reserved for medical related uses and can build on the current assets the area offers.
 - Vacant land could be used to attract world class cancer care, medical and biological research facilities, as well as educational institutions
 - The area could benefit from partnerships with the military to provide joint military medicine to provide the best care military members and their families.
 - The Medical Center area will require world class transportation to and from San Antonio
 - More direct flights from airports, and more transportation options to the area
 - "The area's quality of life is directly related to the talent the medical center area brings."
 - Higher quality talent brings a market for higher quality housing, amenities and services.
