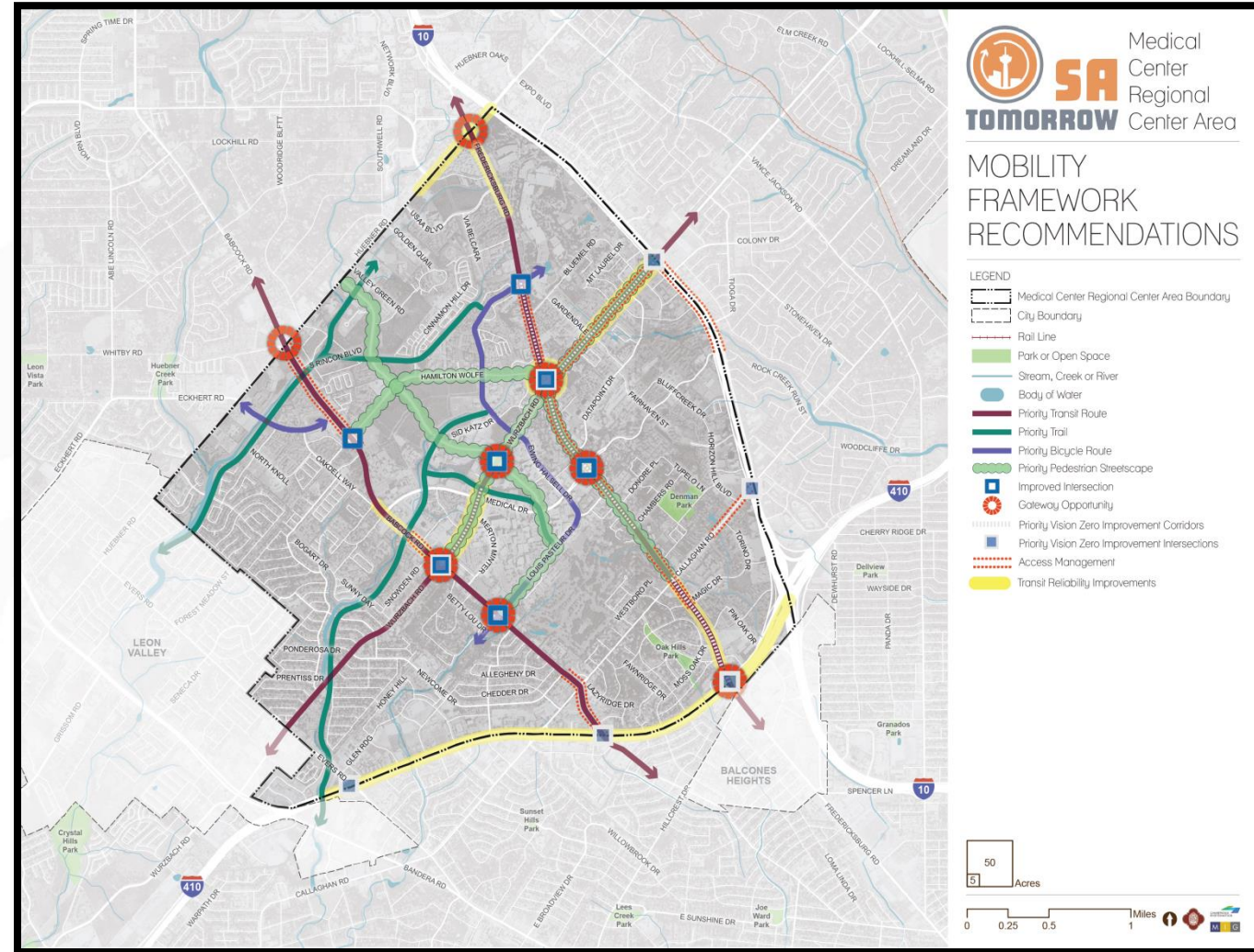
Amenities and Infrastructure
